Canadians' Opinions About Charities

For a third time since the year 2000, the Edmonton-based Muttart Foundation commissioned Ipsos Reid to conduct a survey of the opinions of Canadians concerning charities. The survey, "Talking About Charities 2006: Tracking Canadians' Opinions About Charities and the Issues Affecting Them," which polled 3,864 adult Canadians in mid-2006, was released in September 2006. The study also examines whether public opinion of charities differs by province and "socio-demographic variables such as gender, age, education, household income and religious attendance."

As well, in May 2005, as part of the federal government's Charities Regulation Reform Initiative, the Canada Revenue Agency conducted a baseline survey of 1,533 adult Canadians about charities and the regulation of charities. Through this survey, "Thinking About Charities: Baseline Public Awareness Survey" CRA hoped to determine what information the public needs about charities and relay to them how they can obtain it, and to raise awareness of and confidence in CRA's regulation of charities.

This *Charity Law Bulletin* highlights the key findings of the Ipsos Reid Survey, and where applicable, contrasts the results of the CRA Survey.

Meaning of "Charitable Activities"

In a recent technical interpretation (Document #2006-0168601E5, dated October 23, 2006), CRA considered the meaning of "charitable activities" for the purposes of providing guidance on the difference between expenditures on charitable activities and expenditures on management and administration when determining whether a registered charity has met its 80% disbursement quota. In cases where expenditures are partly attributable to charitable programs and partly to management and administration, it is necessary to allocate the expenditures between these two categories and the allocation should be made on a consistent and reasonable basis. For example, a charity has leased a building from an arm's length landlord and the building has an office for a person that devotes 20% of his/her time to administration and 80% of his/her time to charitable activities. The office occupies 10% of the square footage of the building and the remaining 90% is used exclusively for charitable purposes. If the annual rent is \$10,000, the portion of the rent allocated to administration would be \$200 (20% of 10% of \$10,000). Heat and utilities would be allocated using the same formula. In the technical interpretation, CRA recognizes that in practice it is not always easy to draw the line between these two categories and indicates that it has undertaken to review the issue.

Technical Amendments Released by Department of Finance

On November 9, 2006, the Department of Finance released the long-awaited Notice of Ways and Means Motion to move forward with proposed amendments to the *Income Tax Act* containing significant changes affecting charities. A number of the proposed changes will impact the operations of registered charities in Canada in a substantial way, including the definition of "gift," split-receipting, designation of charitable organizations and public foundations, revocation of charitable registrations, etc. The proposed changes were last released by the Department on July 18, 2005, which amended and consolidated earlier proposed amendments released in 2002, 2003 and 2004. The amendments proposed in July 2005 have been summarized in *Charity Law Bulletin* Nos. 76 and 77, available at our website. A *Charity Law Bulletin* will be posted on our website shortly to summarize the difference between the proposed amendments contained in this Notice of Ways and Means Motion and in the July 2005 proposal. Is the Promotion of Ethical Tourism Charitable?

The Federal Court of Appeal recently heard and released a decision (*Travel Just v. Canada Revenue Agency*, 2006 FCA 343, dated October 24, 2006) involving the refusal by CRA to register a charity with the object "to create and develop model tourism development projects that contribute to the realization of international human rights and environmental norms." The Court concluded that the organization's objects were vague and subjective and were not sufficiently analogous to purposes already recognised by the Courts under the fourth category of charity: other purposes beneficial to the community. In addition, the language left open the possibility of the organization financing and operating luxury holiday resorts, activities with a strong commercial and/or private benefit aspect. In finding that the law of Quebec did not apply to the determination of whether the organization's activities are charitable, the Court indicated that there was no evidence of a connection with Quebec and that "there is considerable force in the submission of the Minister" that the issue of whether an organization is charitable for the purposes of the *Income Tax Act* is a public law concept, rendering the private law of Quebec irrelevant.

New Anti-Terrorism Legislation Briskly Making Its Way Through Parliament

Bill C-25, *An Act to amend the Proceeds of Crime (Money Laundering) and Terrorist Financing Act and the Income Tax Act and to make a consequential amendment to another Act, is briskly making its way through Parliament.* Bill C-25, introduced on October 5, 2006, was passed by the House of Commons on November 10, 2006, and is now before the Senate, which returns from adjournment this week. The proposed amendments in Bill C-25 would greatly increase the level of information sharing and collection among virtually all federal agencies that would potentially investigate or bring charges against charities and their directors and officers (see *Charity Law Update*, October 2006, for more information).

The Legal Context of Nonprofit Management

The chapter covers the legal environment, including applicable legislation; the types of legal structures for nonprofit organizations; and the types of registered charities under the *Income Tax Act*, as well as risk management and liability.

Nonprofit organizations come in many shapes and sizes and are referred to by different names depending upon the context of the discussion, particularly with respect to the legal environment surrounding the discussion. It is important to recognize that while all charities are nonprofit organizations, not all nonprofit organizations are charities. As such, care should be taken when referring to such organizations. Additionally, despite the growth in number and size of charitable and nonprofit organizations in Canada, changes to the legal framework from both the federal and provincial governments have not kept pace, still relying heavily upon concepts developed in the seventeenth and nineteenth centuries, thereby leaving the distinction between the various types of charities and nonprofit organizations in a somewhat confused state. This is particularly so for members of the public, who often use the terms interchangeably.

Branding & Trade Marks Handbook for Charitable and Not-for-Profit Organizations

Trade mark law is perhaps one of the oldest, most pervasive and complex areas of intellectual property law, elements of which can be traced back to the ancient Egyptians. Trade marks can be found at common law as well as in statutes and treaties, and can be found in both the national and international contexts. Perhaps because trade marks are generally associated with commerce — most public trade mark disputes are over high-profile commercial brands — charitable and not-for-profit organizations generally do not recognize the importance of trade marks in their non-commercial world. ... 
