

#### **Donations of Premium Points**

On July 18, 2006, the Canada Revenue Agency ("CRA") released its most recent technical interpretation with respect to donations of airline tickets obtained through the redemption of airline reward points. With the increasing use of such reward or "premium" points in conjunction with customer loyalty programs, many individuals and charities have been presented with various opportunities to benefit from donations of premium points. This bulletin will discuss CRA's policies with respect to donations of premium points and will explore the options for such donations.

#### Tax Shelters and Charitable Donations – a Miss-Match

Both the Department of Finance and Canada Revenue Agency have been attempting to shut down tax shelter donation arrangements, including buy-low donate-high arrangements, leveraged cash donations, and gifting trust arrangements with various amendments to the *Income Tax Act* (Canada) since 2003, and reassessing taxpayers involved with such donation tax shelters. This paper makes the case that these donation tax shelters should be shut down because there is no justification to support tax concessions that exceed the value of the donations being given to taxpayers, whether it is gifts-in-kind or cash gifts, and resulting in a net economic benefit to the taxpayer. The paper also reviews the status of draft legislative amendments made to curtail these tax shelter arrangements, the consequences of non-compliance with the proposed changes, and their impact on those involved in donation tax shelters, including taxpayers, promoters, advisors, appraisers, and charities. Further, the paper also reviews the various steps taken by Canada Revenue Agency to shut down abusive donation tax shelters schemes and their effectiveness.

The revised *Registered Charities: Application for Re-Designation* (form T2095) and the revised *Registered Charities: Application to Reduce Disbursement Quota* (form T2094) are now available at the CRA website: <a href="http://www.cra-arc.gc.ca/tax/charities/">http://www.cra-arc.gc.ca/tax/charities/</a>. Also, on August 25, 2006, CRA announced a new process for reregistration of charities whose status has been revoked for failure to file their annual return (T3010). As of September 1, 2006, organizations re-applying for registration as Canadian charities may be subject to a penalty depending upon their taxation year and when they received their Notice of Intention to revoke. #### Canadian Charities: The Forgotten Victims of Canada's Anti-Terrorism Legislation

Charities, both in Canada and worldwide, have become one of the silent victims of the global anti-terrorism initiatives that have been carried out during the past five years. Part of the impact of Canada's anti-terrorism legislation may have as much to do with coping with a fear of the law as it will with coping with the law itself. This "shadow of the law" effect has already created a chill upon charitable activities in Canada, as charities hesitate to undertake programs that might expose them to violation of anti-terrorism legislation, and with it the possible loss of their charitable status. This Bulletin will help charities and their advisors to understand the basics of Canada's anti-terrorism legislation so that charities will be able to better understand what due diligence steps should be taken in order to avoid violations of the legislation.

## **Supreme Court of Canada News**

On September 21, 2006, the Supreme Court of Canada granted leave to appeal in the case of *A.Y.S.A. Amateur Youth Soccer Association v. Canada Revenue Agency* (F.C.A.) (31476). In that case, the organization, which was established to promote amateur youth soccer in Ontario, was refused registration as a charitable organization on the basis that the promotion of sport is not recognized as a charitable purpose at common law. The applicant lost its appeal to the Federal Court of Appeal (see the related notice in the April 2006 Issue of *Charity Law Update* available at <a href="http://www.carters.ca/pub/update/charity/06/apr06.pdf">http://www.carters.ca/pub/update/charity/06/apr06.pdf</a>) but its appeal of that decision will now be heard by the Supreme Court of Canada.

### Split-Receipting

With respect to the application of the proposed split-receipting legislation, CRA recently issued an advance income tax ruling in a situation involving the donation of a work of art to a Museum which provided a loanback of the work to the donor for the remainder of his or her life. While CRA could not rule on the application of the proposed legislation, it provided an opinion to the effect that the advantage resulting from the loanback would not invalidate the gift, that the eligible amount of the gift would be its certified fair market value of the work less the amount of the advantage accorded in respect of the loanback, and that, assuming the work qualified as cultural property within the meaning of the definition of "total cultural gifts" in subsection 118.1(1), proposed subsection 248(35) (new deemed fair market value rules) would not apply (CRA Document 2006-017039, in French).

## **Budget 2006 Update: Provincial Harmonization**

In an announcement dated August 3, 2006 (http://www.fin.gov.on.ca/english/tax/2006/infdonate.html), the Ontario Ministry of Finance indicated that it would introduce legislative measures to ensure that the provincial tax treatment of donations of publicly-traded shares and ecological gifts would parallel the federal measures announced in the 2006 federal Budget (http://www.carters.ca/pub/bulletin/charity/2006/chylb94.htm), and that both would be exempt from the provincial Corporate Minimum Tax (CMT). Similarly, the Quebec Government confirmed that it would ensure that measures are introduced to eliminate the provincial tax on capital gains resulting from gifts of (http://www.finances.gouv.qc.ca/fr/documents/ publicly-traded shares and ecological gifts bulletin/pdf/bi2006-2-f-b.pdf). In addition, as part of the 2006-2007 provincial budget, the Government extended similar capital gains treatment to gifts of musical instruments to educational institutions and added a new category of organizations authorized to issue provincial donations receipts: cultural or communications organizations. #### **B.C.** Law Institute to Study Not-For-Profit Incorporation Statute

The British Columbia Law Institute began a major project this past summer to look at reform of the *Society Act* – the provincial not-for-profit incorporation statute. The last enactment of the current statute was nearly 30 years ago, with only minor changes since then in connection with procedural and reporting requirements. As there have been few changes to the legislation since it was enacted 30 years ago, this reform should take into account a wide array of changes in both corporate law and the voluntary sector. British Columbia recently enacted the *Business Corporations Act*: a new and streamlined for-profit corporation statute which its not-for-profit counterpart must now attempt to emulate. Federally, the *Canada Corporations Act* may be replaced by the *Canada Not-For-Profit Corporations Act*. (Bill C-21 died on the order paper when Parliament prorogued for the 2006 federal election and there is presently no indication if and when the bill will be reintroduced.) Provinces which have not already begun legislative reform to not-for-profit corporations would do well to follow British Columbia's example, as a new legal framework is required in the voluntary sector where a myriad of changes have taken place over the past three decades.
