## **NEW PUBLICATIONS**

#### March 2004 Federal Budget Rewrites Tax Rules For Charities

by Terrance S. Carter and Theresa L.M. Man in Charity Law Bulletin No.41, March 30, 2004.

The Federal Budget announced on March 23, 2004, (the "2004 Budget") represents a major initiative by the Federal Government in rewriting the tax rules concerning the taxation and administration of charities. The 2004 Budget reflects to a large extent the proposals of the Voluntary Sector Initiative's Joint Regulatory Table contained in its report of March 2003 "Strengthening Canada's Charitable Sector: Regulatory Reform", particularly as it relates to intermediate taxes and sanctions. The 2004 Budget also rectifies a number of technical problems regarding disbursement quotas involving charities, most of which were identified in submissions by the Charities and Not-for-Profit Law Section of the Canadian Bar Association over the last three years.

**February 27**, **2004**, **Revised Draft Amendments to the** *Income Tax Act* Affecting Charities *by Theresa L.M. Man and Terrance S. Carter in Charity Law Bulletin No.40 March 29*, 2004.

On February 27, 2004, the Department of Finance (the "Department") released Revised Draft Technical Amendments to the *Income Tax Act* (the "Act") (the "February 2004 Amendments") that will impact how charities operate. Only those proposed amendments that affect charities are summarized in this article. The February 2004 Amendments constitute a consolidation of and further amendment to previously proposed technical amendments introduced by the Department on December 20, 2002 (the "December 2002 Amendments") and on December 5, 2003 (the "December 2003 Amendments") at 6 p.m. The effect of these changes on the December 2002 Amendments and December 2003 Amendments have also been summarized in greater detail in an article by the authors entitled "Recent Changes to the *Income Tax Act* and Policies Relating to Charities and Charitable Gifts".

#### Criminal Code Amendments Bill C-250 (Hate Propaganda)

by Bruce W. Long (Counsel) in Church Law Bulletin No. 2, March 11, 2004.

A Private Members' Bill was introduced in 2002 to the House of Commons as Bill C-250, *An Act to amend the Criminal Code (hate propaganda)*. Bill C- 250 was given third reading on September 17, 2003. The Bill died in December 2003, but was re-introduced into the House of Commons on February 2, 2004, and received second reading in the Senate on February 20, 2004. Bill C-250 seeks to add sexual orientation as an "identifiable group" which will receive additional protection from hate propaganda. This *Church Law Bulletin* comments on Bill C-250 from the standpoint of its impact on churches and religious charities in Canada.
