## **ULCC Recommends that Provinces Enact Charitable Fundraising Legislation**

by Terrance S. Carter, assisted by Nancy E. Claridge in Charity Law Bulletin No. 79, October 14, 2005.

The past five years have in some respects been a difficult time for charitable organizations in Canada as a result of a series of print and television news reports detailing various abuses by a number of charities and fundraising businesses, and two egregious cases in 2001 and 2002 where Ontario's Public Guardian and Trustee was forced to step in and obtain a court order for the "charitable" organizations to pass accounts. Although the fundraising practices of "the overwhelming majority of charities and charitable fundraisers are ethical and beyond reproach," the unsavoury practices of the minority was prejudicing the reputation of the vast number of legitimate charitable organizations in Canada. It was within this context that the Uniform Law Conference of Canada ("ULCC") stepped in to help move the sector forward. At their 2005 meeting in St. John's, Newfoundland, the ULCC passed a resolution adopting a *Uniform Charitable Fundraising Act*, and recommended that it be enacted by both the provincial and territorial governments. This *Charity Law Bulletin* reviews the legislation and compares it to similar initiatives in other jurisdictions.

## **New CRA Policy on Umbrella Organizations**

This *Charity Law Bulletin* provides a brief overview of the draft policy entitled *Guidelines for the Registration of Umbrella Organizations* that was released by Canada Revenue Agency ("CRA") on July 29, 2005. The initiative CRA has taken in its initial draft of the Guidelines is a positive development that will be of assistance in facilitating the establishment of umbrella organizations to assist other registered charities and for the protection of charitable assets. However, there are aspects of the draft policy that will require further consideration by CRA.

## The Employer's Duty to Accommodate: Religious Observances and Beliefs

by Anne-Marie Langan and Mervyn F. White in Church Law Bulletin No.13, September 27, 2005.

In Ontario, employers are prohibited from discriminating either directly or indirectly in employment on the grounds of race, ancestry, place of origin, colour, ethnic origin, citizenship, creed, sex, sexual orientation, age, record of offences, marital status, family status and handicap. Employers have a duty to accommodate their employees, who are members of one of the identified groups, to the point of "undue hardship." This *Church Law Bulletin* explores in detail the scope of an Ontario employer's duty to accommodate employees who have religious beliefs that have come into conflict with one of the employer's policies, providing recommendations to employers on how to avoid liability by making appropriate accommodations for these employees.

## Advancing Religion as a Head of Charity - What are the Boundaries? (Revised)

by Terrance S. Carter, September 29, 2005.

This paper is a significantly updated version of a paper that was originally presented for the CBA/OBA 3rd National Symposium on Charity Law on May 6, 2005, that takes into account recent legal developments, as well as provides additional commentary. It provides an explanation of the historical perspective concerning advancement of religion as a head of charity by examining the case law that has been most influential in defining the scope of advancement of religion. A discussion then follows regarding how the Charter has impacted the definition of religion and may impact advancing religion as ahead of charity in the future. Finally, an analysis is provided of recent developments in Canada concerning advancement of religion compared with parallel developments in other jurisdictions, some of which have attempted to provide, or are currently in the process of providing a legislative definition of advancement of religion.

# The Impact of Anti-Terrorism Legislation on Charities: The Shadow of the Law (Revised) by Terrance S. Carter, September 27, 2005.

This paper is an update of an earlier version that was presented at the New York University School of Law in October 2004, and takes recent legal developments into account, as well as provides additional commentary. It examines Canada's recent legislative initiatives to combat terrorism and their impact on Canadian charities and those who advise them. Charitable activities that were until recently thought to be commonplace and uneventful may now lead to a charity becoming susceptible to criminal charges for having facilitated "terrorist activities" or for supporting "terrorist groups." This, in turn, could result in the charity losing its charitable



status and its directors being exposed to personal liability. In addition, financial transactions involving charities may lead to allegations of terrorist financing or to the surveillance and monitoring of a charity's financial activities. While it is difficult to say what the long-term impact of Canada's anti-terrorism legislation will be, it is clear that it will have a profound impact upon the charitable sector and Canadian society in general.
